Dear Steve.

Platform paddle tennis has its origin in Scarsdale, and the Fox Meadow Tennis Club holds the distinction of being the "Founder Club".

The American Platform Tennis Association was established in 1934 by representatives of Fox Meadow, Manursing, and the Greenwich Field Club. Since that date, officers of the Executive Board of the APTA have come from clubs in the metropolitan area, and Fox Meadow has always been strongly represented. The tie between Scarsdale, the birthplace of the game, Fox Meadow, and the APTA has always been strong. We feel this is fitting and that this ties should be maintained.

The APTA has never had a "physical focal point", so to speak. There is no one place where files or memorabelia are kept, or where meetings are held. Many meetings, but not all, are held at Fox Meadow, and as you know provision for such meetings at the club are makeshift in nature and not top-drawer.

With the above in mind we would like to propose for your consideration the stablishment of a room at Fox Meadow to serve as an Executive Committee meeting room for both the APTA and the Fox Meadow Board as well as a place for storage and display of APTA records and trophies.

We visualize that such a room could be constructed by utilizing the present storage area beside the kitchen plus a portion of the southeast corner of the new room. Alternate storage area, it is recognized, would be a problem but this could be studied and hopefully worked out.

I have discussed this in general terms with you and other fambers of the FMTC Board and have received a generally favorable reaction. If this broad overall proposal meets with your approval we would appreciate the opportunity to sit down with you or your designee(s) to discuss the subject in further detail.



The Board voted to host the National Mixed Doubles Tournament to be held on February 17, 18 and 19. The Board's approval was given subject to our receiving the same compensation which we received last March for hosting the Mens' Nationals, which I believe was \$250, plus a commitment from the APTA to pay for all snow removal costs incurred in connection with the tournament, other than the cost of the normal plowing which is done for us under a season contract. As you know, this additional snow removal cost usually involves high school boys and chemicals. Much of the work is usually done by volunteers.

BASIC CONCEPT: To build, if space, economics, zoning, and other considerations permit, a Room to be used for


- Meetings (FM Board)

- Tasteful display of records of national champions, Honor Award winners, possibly past Presidents, etc., FM Past Presidents,
- Storage and/or display of memorabilia such as old paddles, photographs, books, etc.

The room would be used as a Board Meeting Room by both the APTA and the Fox Meadow Board, and might also, with suitable decor, serve as the game's equivalent to the Hall of Fame .

THE ROOM: The room is pictured as being carpeted, with a large oval (or other shape) meeting table surrounded by chairs; paneled, with waist-high cabinets for storage, with file cabinets within portions of the panel-front cabinets; upper cabinets around some of the walls for display/storage, with other portions of the walls open for hanging plaques, pictures, etc.

APPROACH: The following approach to the project is suggested:

- Joint APTA/FMTC committee meet to discuss (1)basic concept, to define possible locations for the room and problems to be faced.
- (2) Obtain architectural assistance and advice and draw up rough plans and cost estimates for the one or more locations defined in (1)
- (3) Select the best location
